## Consent, Service, Waiver, & Release Agreement

1. OWNERSHIP. Owner is the legal owner of the Pet and has the authority to enter into this Agreement with The Posh Paw Resort (the "Pet Resort"), to grant the consents and waivers & releases, and to make the declarations, promises, representations and warranties contained herein.
2. CONDITIONS FOR SERVICE. Pet Resort may, in its sole and absolute discretion, refuse to service or discontinue any service to Pet and/or Owner at any time concerning Boarding, Day Care and/or Grooming Clients. Pet Resort requires Pet to have its entire series of vaccinations current.
3. CONSENT FOR SERVICE. Owner acknowledges, agrees and declares that the services have been described, and that Owner authorizes and grants consent to Pet Resort to perform

said services. Owner agrees to pay, in full, for any and all services rendered prior or at the time of pick-up and removal of Pet.

4. VETERINARY SERVICES. In the event Pet becomes ill, injured or requires veterinary care in Pet Resort's sole and absolute discretion, owner hereby authorizes Pet Resort to obtain veterinary care for Pet. In the event Pet becomes ill, injured or requires veterinary care, Pet Resort may, in its sole and absolute discretion depending on the matter, attempt to contact Owner. If Pet Resort is unable to contact Owner, then Pet Resort shall obtain for Pet veterinary care, to the extent as is deemed necessary or desirable in treatment of Pet, and shall reimburse Pet Resort for any and all fees and expenses disbursed on Pet and Owner's behalf or at Pet Resort's direction forward such payment directly to Veterinarian. Owner agrees and allows medical records and/or history to be released to the Pet Resort.

5. PHOTOGRAPHIC SERVICES. Owner acknowledges and agrees that Pet Resort retains all right, title and ownership in, and to, any photographs, pictures, videos, images, digital images, or any other forms of media presently or future known (the "media") taken of Pet. Pet Resort may, in its sole and absolute discretion display, reproduce, publish, alter, vary, or make any use of the Media as it deems necessary or desirable. Owner further hereby declares that it waives and disclaims any right, title, interest and ownership claims in and to, the media, and further acknowledges and agrees that Owner is not entitled, in any way, entitled to any compensation for any present or future use of the Media by Pet Resort.

6. WAIVER & RELEASE. Owner acknowledges and agrees that in relation to the performance of any service and/or veterinary service or care of pet that certain risks and hazards may exist, and that various circumstances and conditions may exist or arise which may result in loss, injury, or death to Pet or Owner, Owner hereby waives any claim, and releases Pet Resort, its agents, assistants, employees, members, managers, principals, and staff, from any claims suits, and/or allegations of wrongdoing or negligence in relation to the, direct or indirect, performance of any service and/or veterinary care of Pet for any loss, injury or death to Pet and/or owner or person associated with, accompanying, or appointed by Owner.

7. FEES. Pet Resort may, in its sole and absolute discretion, require a deposit or prepayment in any amount it deems necessary or desirable for any service to Pet. All fees and prices are subject to change without notice.

8. FOOD ALLERGIES. In the event that Pet Resort food must be provided to Pet, Owner acknowledges Pet to have no known allergies to food and approves use of Pet Resort food.
